## CAR SHOW INFORMATION & INSTRUCTIONS

- Eligibility:** Vehicles from the 1980's or older (original or modified) that are fully enclosed or convertible 3- and 4-wheel motorized vehicles (i.e. automobiles and trucks) are eligible to participate, including replicas and race cars. This would not include 3-wheel motorcycles and scooters.
- Awards:** "Best In Show" each to pre-1950, 1950-1989 and 1990-2008 vehicles, original/restored and modified.
- Fee:** Pre-registration is \$10 with completed registration form. Same day registration will be \$15.
- Due Date:** Pre-registration form and fee must be received by July 30, 2018. Notification of your entry will be acknowledged by email or text message.
- Location:** Registration Tent will be located on the east side of the Dutton Fire Department - 3471 68<sup>th</sup> St SE, in downtown Dutton.
- Staging:** Entries will be staged as directed by Dutton Days officials between 5:00 and 6:00pm. Entries not in their assigned location by 6:00pm may be denied entry to the show. Vehicles and trailers used to deliver entries or people to assigned location may be parked in designated locations nearby at the direction of Car Show officials. Once in place, entry vehicles are not to be moved for safety and damage prevention.

## CAR SHOW POLICIES

1. A signed Registration is a commitment to participate in the show. At the sole discretion of Dutton Days officials, registered participants may be asked to remove their vehicle if its condition or the conduct of the registered participant(s) is deemed detrimental to the safety and enjoyment of the event by others. A limit to the number of entries may be imposed and/or waiting list created if the number of registrations fills the available venues.
2. Dutton Days reserves the sole right to refuse to accept Registrations from, and/or to remove from the car show, any entry which does not fit with the standards of the sponsoring organization, may not be in the best interests of the community, or does not comply with this Registration.
3. Open flames, the possession and/or consumption of illegal substances, dangerous display or behavior with weapons or objects used as such are NOT permitted at any time while staging for, or participating in, the Show.
4. Dutton Days, Community Services of Dutton, the Kent County Road Commission and any affected property owners are not responsible for entries' vehicles, damage to them while participating in the event and personal property, including property left unattended at any location. Event attendees will be reminded to look and not touch entries without the permission of the entry's owner.
